### \*Inogen G3 Portable Oxygen Concentrator (POC)

Max. Oxygen Output: 5 LPM (pulse dose only)  
Max. Battery Duration: 1.7 hr @ 5 LPM pulse.  
**Weight: 5.8 lbs w/ 16 cell battery. Includes shoulder carry bag.**  
(Private rental only)

### \*IVC Solo II Portable Oxygen Concentrator (POC)

Max. Oxygen Output: 3 LPM continuous, 5 LPM pulse dose  
Max. Battery Duration: 1.5 hr @ 3LPM contin.  
**Weight: 20 lbs without attachable cart.**  
(Private rental only)



**POC are NOT to be used in conjunction with any other device, sleep apnea device, or used overnight.**

### FAA POC requirements:

1. MUST have 150% of their actual flight time in battery time, regardless of how long the user may choose to use the device as a carry-on item. (If you carry your POC on board but do not intend to use it while in flight, you are still required to follow FAA battery requirements).
2. MUST complete a POC Battery Approval Request form and submit it to your airline at least 48 hours prior to travel.
3. MUST contact your airline for any additional forms or for further assistance
